LOCAL ASSOCIATION CONSTITUTION

Amendment No. A-4

Article 6, Item b, Board of Directors. Add an alternative for associations with less than 250 members to have a smaller board. *Proposer:* William G. Chestnut, ABC Life Member, Cantrall, Ill.

Amendment No. A-5

Article 6, Item e, Nominations And Elections. Allows board members to bowl unsanctioned leagues as long as they bowl in a sanctioned league.
