## **"ABSENT" TEAM CAPTAIN PLAYS ROLE IN RECORD SERIES**

How would you feel if your five-man team established association and state records for a three-game series ... and all you could do was watch it happen? That was the situation in which team captain Rusty Crawford found himself on December 10, 2013, four days after undergoing knee surgery when he witnessed his "Double Platinum" crew—minus one, of course—do exactly that, scoring 3,870 at Crofton Bowling Centre (see page 5). He noted the 1,371 first-game total and ultimate tally could have been perhaps 30 pins higher but that anchorman Don Messinese, who leads the league in average at 235, opened in the final frame. While Crawford, who averages 230, didn't bowl, he can take some of the credit: Steve Scott was his personal choice to take his place that evening. "I'm just glad I got a good sub, that's all I can say," said Crawford. "He shot 761. They bowled very well; it was an awesome experience to watch."

## PRESIDENT'S MESSAGE • GENE O. MAYS

### *Has your league prepared for a smooth payout process?*

The bowling season for many leagues is entering the three-quarters mark and soon will be over. With this fact in mind:

- First off, league officers should make sure that all bowlers are in good standing and they are certified with this association.
- It is now time for all league officers to make sure the finances are correct so that there will not be any problems at season's end. Towards that end, presidents should have their audit committee in

place as specified in the rule book. The committee's report should be made available to all league members.

- It is also the president's responsibility to make sure the payoff process runs smoothly and without controversy.
- The league secretary should make sure that the final averages are sent to the association office as quickly as possible upon completion of the season.

We should make sure that correct procedures are followed at all times. You are advised to contact your lane director or the association office for any additional information. I have visited with several leagues and most of the bowlers in them seem to be pretty well satisfied with the way their league is functioning.

## MANAGER'S MEMO • RONALD MCGREGOR

### *Delegates to consider important amendments*

This year's Annual Membership Meeting will be held March 16 at Bowl America Gaithersburg, beginning with lunch at noon and the general session to follow. There will be a bylaws change up for consideration along with several other topics that will, I'm sure, challenge your comfort level with bowling and the direction it seems to have taken.

USBC has released this year's slate of amendments (see page 10) that will be under consideration at its annual meeting April 24-25 in Reno, Nev., and you will notice that over two-thirds of them deal with dues changes. As you may be aware, starting next season, your local association will be responsible for paying for awards that USBC has handled as "special achievement" awards for many years. NCAUSBCA currently is considering awards program options, but these options likely will depend on the passage of some of the amendments at the USBC Annual Meeting. Careful consideration of these amendments by all members is necessary because if dues increases are not approved, our association may not be able to afford an awards program.

Therefore, I encourage you to review the amendments and pres-

ent your views to the association's board of directors at the March meeting. Delegates are elected to represent your views at the USBC Annual Meeting, so be prepared to make your views/wishes clear so that they can carry your message to the April meeting.

March 17 is the deadline date for entries for the **NCAUSBCA 69<sup>th</sup> Annual Open Championship Tournament**. Spots are filling up quickly, so don't hesitate to get your entries in to the office or hand them to your league representative. If you do not have a team and wish to bowl, you can send in your money, and I will place you on a team.

The team event will be at The Lanes Fort Meade, and the singles/doubles are at Bowl America Shirley. We have added some new events and changed the team event to a four-person team in part from suggestions made by your fellow bowlers. Participation will determine if the change lasts.

As a reminder to the scratch bowlers, \$19 of the \$20 fee is prize money, so there should be a good amount of money for which to compete.

## *Staying calm under pressure; bowling alongside beginners*

**Q.** *I have never shot a 300 game, but last month I did get the first nine strikes in a row. Then I got so nervous I missed the headpin and left the 1-2-4. Can you give me some hints on how to stay calm under pressure?*

**A.** Everybody handles pressure differently, so there is no set way to answer this question, but I will give you a few things to try. Pick one or two, and use them the next

time you are under pressure and see if it works for you.

I use distraction for myself; I count in my head before taking my first step to the line. I use *one thousand one, one thousand two, and one thousand three*, all while looking at my mark, then go to the line. This for me takes my mind off the consequences of the shot and allows me to relax and just hit my target.

You can use mental imaging: In your mind, see yourself throwing

the shot and the shot being successful.

For some, minimizing the value of making the shot can work, like remembering a 300 game is not 12 strikes in a row—a 300 game is one strike in a row 12 times. Each shot is a separate game.

**Q.** *I bowl in a mixed league that has many top bowlers in it who take the game seriously. Our problem is the center has open lanes next to our league, and they put people with kids and beginners on the open pair next to us. We have asked them to leave a buffer pair dark, but they don't listen. Can we get help from USBC on this matter?*

**A.** I feel your pain, but this is not a problem that USBC can help you with. They can't tell the center to leave a pair open between you and the rest of the lanes; you will have to figure out a way to handle this with the center.

Most centers will leave a buffer pair dark, but they need to make money, so if they are getting full, you can't blame them for wanting to use the lanes.

Here is my suggestion: Go to the manager or owner and first ask to leave the buffer pair dark until it is absolutely needed; this not an unreasonable request. Then, in case it is needed, if they could at least make sure the people they put on that pair are league bowlers since they at least would know the etiquette of the game. They may have to move some bowlers onto that pair from another pair.

If you explain your concerns to them in a nice way, most businesses will oblige.

## New squad times and tiered pricing for 2015 USBC Open Championships

RENO, Nev. — Registration for the 2015 United States Bowling Congress Open Championships is set to begin March 13, and changes for the tournament's first visit to El Paso, Texas include variable pricing and new squad times.

USBC will implement a tiered pricing structure for entry fees based on the day of the week teams choose to compete. The new squad schedule means no early mornings or late nights for competitors.

The Standard price point will serve as the foundation of the tiered structure, keeping entry fees in line with previous events—\$55 per event and an optional \$15 for all-events—for a total of \$180 per bowler.

Value pricing will be offered for select squads, often mid-week, and include incentives for bowlers. The entry fees will be the same as the Standard level, but competitors who choose these times will receive \$15 in Championships Cash vouchers when they check in at the El Paso Convention and Performing Arts Center. Championships Cash can be redeemed for purchases inside the venue, such as food and beverage, merchandise, select brackets products, and more.

Premium pricing, which primarily will include Friday and Saturday team squads, will be an additional \$75 per team. However, teams that act fast and register (paying for team event and premium fee) by June 13, 2014, will be eligible for \$20 in Championships Cash per bowler upon checking in at the 2015 tournament.

Any day not listed as Value or Premium will feature Standard pricing and no change in price.

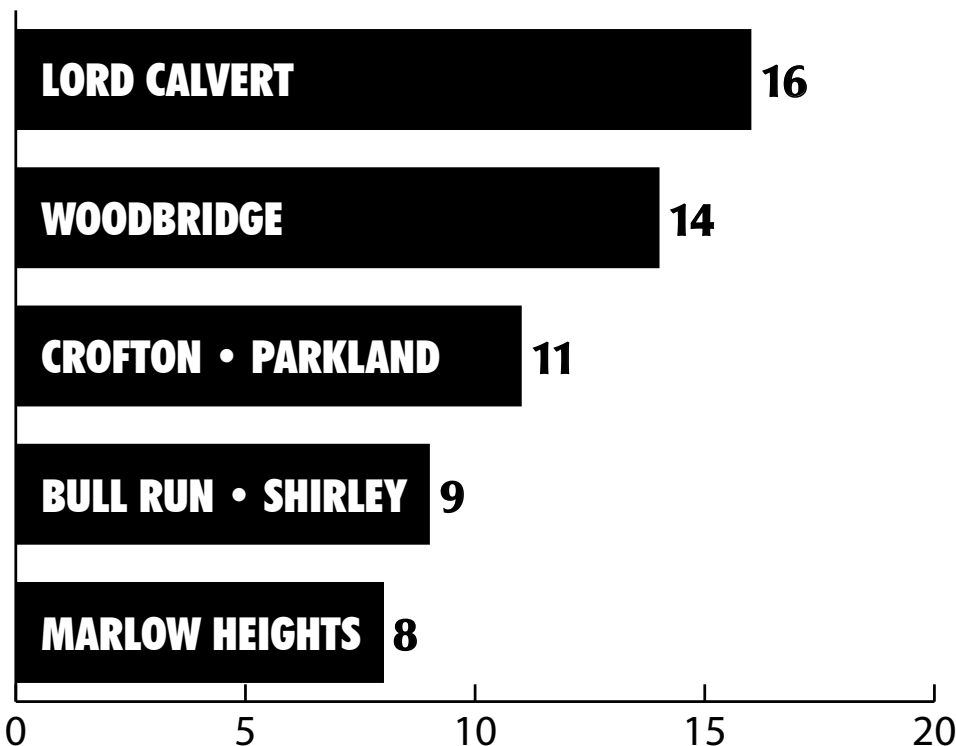

# The Best Bowling Tip I Ever Received

The best bowling tip I ever received came from Ko Whittington. I was talking with him one day about different ways to play the lanes. That's when he told me that sometimes he aimed at the camera all the way down the lane, as one of his methods. It was then that a light bulb went off, and I went from just aiming at the arrows as a targeting method and stepped out of the box and started aiming all over the lane.

This general idea taught me how to create different angles, rolls, and helped me adjust more than just left and right. I went from being a 200-average bowler to a 230-plus average bowler in two seasons.

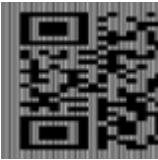

# **15<sup>th</sup> Annual Guys & Dolls Tournament Rules**

1. **The Tournament is open to any bowler providing proof of a 2013-2014 USBC Membership and current book average, or a final 2013-2014 league standings sheet.**
2. Bowlers must present a USBC membership card and confirm lineup **as shown on entry form** in the tournament office **45 minutes prior** to scheduled start time. Teams or bowlers failing to appear on the lanes, prepared to bowl at the scheduled time, shall forfeit their entry unless sufficient reason is given to warrant postponement.
3. Bowlers entered in the singles event must also enter the doubles event and visa-versa.
4. The Team captain, or his legal representative, has the privilege of substituting other bowlers for those originally entered. Only same sex substitutions will be accepted. In the doubles event, the names of both entrants must be given. Entries with the word "**PARTNER**" will not be accepted. Each Team **MUST** consist of 2 Men and 2 Women, and Doubles **MUST** consist of 1 Male and 1 Female.
5. The Doubles event will be held immediately following the Singles event. **SINGLES is Bowled First.**
6. All entrants will bowl 3 games on one pair of lanes in each event, unless mechanical failures dictate otherwise. No entry money will be refunded if it is discovered that a team or individual has failed to comply with all rules of the United States Bowling Congress and all rules and requirements of this tournament.
7. **Handicap will be 90% of the difference between the bowler's entering average and a scratch figure of 230 All handicaps will be calculated on a 3 game basis. It shall be the responsibility of each bowler to verify his or her average. Failure to use proper average shall disqualify scores bowled if submitted average is lower than actual average. Prize winnings will be based on submitted average if it is higher than the actual average. Average corrections must be made prior to the completion of the **FIRST GAME.****
8. **USBC RULE 319a(2) WILL APPLY. 10 PIN RULE** If your average this season is 10 or more pins higher than last season, this year's average will be used.
9. If a bowler does not have a 2012-2013 yearbook average, the bowler may use the highest current certified average (of 21 or more games) as of the closing date for entries of the tournament (**May 31, 2014**), otherwise they must enter with an average of 230. If using current average, a league sheet showing average as of May 31, 2014 must be provided to Tournament Officials at check-in. **If bowler does not have a yearbook or current average and competed in a summer league, that average, of at least 21 games, may be used provided it is verified at the tournament office. USBC Rules 319 c, d, & e will apply.**
10. The prize ratio for each event will be one prize for each five entries. Lineage and Expense = \$12.50, Prize Money = \$12.50 per bowler per handicap event. **PRIZE MONEY WILL BE RETURNED 100%.**
11. In the event of a tie for first place (team, doubles, singles) the tied contestants will bowl 3 games in accordance with the rules of the tournament at such time and place as decided by the Tournament Manager. Total pins, including handicap, for the 3 games will determine the winner. In the event of a tie for first place in the All Events, USBC Rule 326a will apply. When there is a tie for any championship in a tournament, it is optional with tournament management to have a playoff or declare co-champions.
12. **Entrants must report any previous tournament prize winnings in the last year of \$ 600.00 or more in total. If entrant has won \$600.00 or more in total prize winnings for a tournament, he/she must submit all his/her tournament scores and winnings PRIOR TO BOWLING. USBC Rule 319e**
13. **PARTICIPATION & DRESS CODE RULES**
  - a. **All Bowlers must wear shirts with collars NO EXCEPTIONS.**
  - b. **NO T-SHIRTS or JEANS WITH HOLES may be worn on the lanes.**
  - c. Bowlers may enter doubles 2 times as long as partners change. Bowlers may only cash once in scratch singles, (Highest Score). Bowlers may enter the team event 3 times, as long as 2 members of the team change.
  - d. Only one professional (PBA or PWBA) member allowed per doubles pair, and only 2 per team.
  - e. **NO JEANS WITH HOLES or SHORTs may be worn on the lanes.**
14. Scores lost due to malfunction of automatic scorers shall be re-bowled.
15. Scores for ALL-EVENTS will be taken from the FIRST series bowled in each event. (Team, Doubles, & Singles)
16. USBC Rule 330 will apply. (A bowler must use the same hand to deliver the bowling ball throughout the tournament).
17. USBC Rule 329, a protest or appeal involving eligibility or playing rules must be filed with Tournament Management, the Local Association or USBC up to **5 Days before tournament prizes are paid.** The protest or appeal must be in writing and the grounds for the protest or appeal briefly stated.
18. **A \$ 20.00 ADMINISTRATIVE FEE, PLUS BANK CHARGES WILL BE LEVIED ON ANY RETURNED CHECKS.**
19. **SCRATCH EVENTS:** Bowlers must compete in regular tournament to enter scratch event. Scores from handicap event will be used to determine winners of the scratch event.
