Dear League Supervisor/League Level Coordinator;



A YEAR FOR NO CHANGE! League qualifiers will advance straight to the State Level. Scratch bowlers only advance past the State Level. Fees will remain the same as last year. Scholarships will be awarded at the STATE LEVEL in all divisions.

An estimated **\$12,500** in scholarships will be awarded in this year's tournament. Make sure your bowlers have their opportunity for this year's scholarships.

The 1st and 2nd place STATE LEVEL winners in the 12 & Above Scratch Divisions will receive a paid entry into the 2010 USA Junior Gold National tournament in July 2011 in Las Vegas. A travel stipend will be available to qualifiers. See the State Rules for additional details.

League qualifying will be in accordance with USBC rules included with your league kit. *In case you didn't get the league kit; download the league level handbook from bowl.com. Make sure your bowlers initial the forms confirming their divisions and they are provided with a copy of all level rules.* Qualifying windows for your league qualifying are as follows:

NOVEMBER WINDOW: November 7 - 20, 2010 FEBRUARY WINDOW: January 23 - February 5, 2011

If you need to adjust these dates because of weather or other events at your center, please feel free to do so.

As a reminder, bowlers ages 12 and above (as of 1 August) **must decide before they bowl, whether they will participate in the scratch or handicap division.** They will bowl in the chosen division in this league during the qualifying period. They may choose a different division in a different league.

Enclosed are your copies of the format and rules for the STATE LEVEL competition of the 2011 VIRGINIA STATE PEPSI USBC YOUTH CHAMPIONSHIPS. Also, enclosed is a checklist with the November Qualifiers Form to help you schedule your events and the STATE QUALIFIERS form to list your qualifiers for the STATE LEVEL.

Return the STATE QUALIFIERS Forms (one form per league) with average verifications and STATE LEVEL fees to me as soon as **possible after the end of the February qualifying period.** *Fees are \$16.00 for Division 11 & Under and \$26.00 for Division 12 & above bowlers.* **The STATE LEVEL deadline for submitting qualifiers is March 22, 2010. All entries must be postmarked by March 22, 2010.**

The STATE LEVEL competition will be held at AMF Hanover Lanes, 7317 Bell Creek Road, Mechanicsville, Virginia. Dates will be April 30, May 1, 7, 8, 14 and 15. Squad times will be 10:00am and 2:00pm each day.
